He holds an Associate's Degree in Chemistry and Biology from The University of The Bahamas, and a Bachelor's Degree in Economics from the University of Western Ontario, Canada, and undertook graduate studies toward a Masters in Business Administration from George Washington University, Washington, D.C.

He remains the youngest person in The Bahamas' history to serve in the Cabinet, having been appointed at 29 years old.




