In May 2025, the Caribbean Organization of Supreme Audit Institutions (CAROSAI) hosted its triennial plenary congress in The Bahamas. As part of the International Federation of Accountants (IFAC) Statement of Member Obligations (SMO's), BICA is responsible for demonstrating its best efforts to promote awareness of International Public Sector Accounting Standards (IPSAS) with the Auditor General and the Ministry of Finance, as well as encouraging their adoption and implementation. Given the mandate, BICA was offered five (5) seats to observer the congress sessions.





William "Bill" Wallace was a distinguished leader whose impact spanned accounting, cultural preservation, Greek life, and community service in The Bahamas.

#### **PROFESSIONAL CONTRIBUTIONS:**

Wallace served as Managing Partner of **Parnell Kerr Foster**, significantly shaping the accounting pro-fession in The Bahamas. He was the third President of the **Bahamas Institute of Chartered Account-ants (BICA)** from 1984 to 1986, maintaining an active membership for 46 years and leaving a lasting mark on the organization.

#### **CULTURAL LEADERSHIP:**

A passionate advocate for Bahamian heritage, Wallace chaired the **National Junkanoo Committee**, guiding the growth and governance of this iconic cultural celebration.

#### **GREEK LIFE LEADERSHIP:**

Wallace was a trailblazer in Black Greek-letter organizations. As Chartering Polemarch of The Baha-mas Alumni Chapter of Kappa Alpha Psi Fraternity, Inc., he exemplified leadership, mentorship, and service. Nationally, he broke barriers as the first member outside the continental U.S. to serve on both the Southern Province and National Boards. He was also a founding member of the Delta Lambda Boule of Sigma Pi Phi Fraternity and a Life Member of Kappa Alpha Psi for over 50 years, helping strengthen the presence of Greek-letter organizations throughout the Caribbean.

#### **COMMUNITY AND FAITH:**

A devoted member of **St. Agnes Anglican Church**, Wallace served on the Parish Vestry and participated in the Senior Choir, demonstrating his deep commitment to community and faith.

#### **FAMILY:**

Wallace was a devoted husband to Yvonne Wallace and loving father to Kevin, Roston, and Yvette, embodying the values of family, integrity, and service.

#### **LEGACY:**

William "Bill" Wallace leaves behind a legacy defined by integrity, cultural stewardship, and dedication to uplifting his community. His contributions to professional excellence, Baha and faith continue to inspire those who follow in his footsteps. to uplifting his community. 
